All collection fees incurred by Tamaro Oil while recovering past due balances will be paid for by the account holder(s). Any account that holds a past due balance over 30 days or fails to comply with any credit terms herein is subject to cancellation by Tamaro Oil at any time; at which time said balance will be due immediately.

Any discount(s) on a maintenance contract agreement that you receive from Tamaro Oil are reliant upon automatic delivery status. Removal from automatic delivery renders said discounts invalid. In said case, the account holder(s) then must pay the remainder of the full retail price (an additional \$400.00 per unit covered under maintenance agreement), due immediately, in order to maintain a maintenance agreement. Said monies are not a fee or penalty; but are the difference between a discounted rate and the full price of the agreement. There are no refunds or rebates on maintenance contract agreements.
